First Community Federal Credit Union

First Community Credit Union was present to do a presentation regarding the services that they could offer our township.

Fifth Third

Fifth Third also presented a written proposal together for the board to review for new services that they can offer showing ways to cut down on fees. Kopka motioned to stay with 5/3 with the new proposal that will save the township money on fees, until we have looked at all other banks, credit union and other institutions and what they can offer the township. Budget Amendments

Vandenberg explained that while paying the phone bills for the water system Meert observed that the phone line in the budget for 2012/2013 was over, and reviewing the budget Vandenberg and Meert realized that because we dropped the Miss Dig phone service and went to all email contact, it was assumed that all phone bills would be cut from the budget, however we have a phone line at the well house and need to amend the budget to cover this cost. Pearson motioned to amend the budget line item 591-538-851 in the amount of \$7000.00. Corbin seconded. Corbin yes, Kopka yes, Meert yes, Morrison yes, Vandenberg yes, Moerman yes and Pearson yes. Motion carried.
