#### **Minutes**

Kopka motioned to approve the minutes for February 5, 2009 and February 19, 2009 with one correction on page 2 under federal trade add March 5, 2009. Moerman seconded. Motion carried.

### Approval of agenda

Vandenberg motioned to approve the agenda with three additions PTO/Pension, PTO payout and Fire Asses. Corbin seconded. Motion carried.

### Clerk's Report

Meert presented the board with a list of checks paid for the month of February 2009 and a copy of the enterprise fund report. Vandenberg motioned to accept the report as presented. Pearson seconded. Motion carried.

# Treasurer's Report

Morrison reported that the 5/3 checking balance was \$1,059,121.69, the 5/3 CD balance was \$36,749.00 and the Raymond James Investment fund balance was \$222,300.00. Vandenberg motioned to accept report as presented. Meert seconded. Motion carried.

#### 1. Construction Board of Appeals

Vandenberg reported that we need to form a construction board of appeals according to Kurt Scharphorn from PCI. The board asked Vandenberg to put together and report back to the board.

# 2. Extend Planning Commission member's terms

# 3. Land Information Services (Aerial Imagery)

The county is asking us to pay \$2251.00 for our share of the cost to redo and update the aerial maps of Allegan County including Gun Plain Township. Meert motioned to approve the cost. Pearson seconded. Motion carried.

### 4. Dust Control for 2009

The Township received two bids. 1. Southwest Dust Control in the amount of \$21,000.00 for two applications. 2. Bruce Alan Enterprises, Inc in the amount of \$5940.00 per application or \$17820.00 for three applications. Vandenberg motioned to accept Bruce Alan bids and do three applications for the year in the amount of \$17820.00. Morrison seconded. Motion carried.

# **5.** Cyber Security grant (report)

Vandenberg reported that Tony Clark helped write and submit a grant for the cyber security program and we were accepted 100%.

Corbin reminded the board that he was pleased that the fire department employees received a 2% wage increase.

Kopka asked if we would contact Deputy Roberts and asked him to contact Kopka regarding a few questions on detailing of the new cruiser, Kopka stated that he would like to see the Gun Plain Township logo stand out a bit more.

### **Resolution 2009-1 Identity theft policy**

# 1. Federal Trade Commission: identity theft prevention program

Moerman motioned to get rid of the PTO policy after the March 2009 pay out and pay all employees except the fire department employees a 15% pension. Morrison seconded. Motion carried.
