Resolution 2016 - 5 Increase Sewer Rates

Vandenberg reported that the Township is not increasing the rates to sewer, due to the city of Plainwell decided increasing rates by 3.6%. Resolution 2016 – 6 Increase Water Rates

Warning Siren

Vandenberg reported that West Shore checked on the siren that was not working and found the bushings were bad, so they repaired them. The siren did not have to be replaced. Vandenberg asked board what we wanted to do with the balance of the bill that the County owes Gun Plain Township. Meert motioned to pay the bill for the repairs to the siren and put the balance and an account in writing that Gun Plain can use for future repairs or credit toward a new siren. Vandenberg seconded.
