State Representative Mary Whiteford was present and spoke to the board and public on bills that the house is currently working on in the House. She also took public comments from the board and public.

Resident ask when 6th Street was going to be paved.

New Business

Rezoning Request 357 6th Street (First Read)

The Planning Commission Board recommendation to the board was to deny the request to rezone parcel 0308-027-015-00 from R-2 to R-1. They stated that rezoning it to R-1 would make it a non-comforting parcel. The board did not take action at the July 6, 2017 meeting because it was the first read, the board will take action on this matter at the next regular monthly meeting.

Resolution 2017-7 (Road Culvert)

Resolution requesting the Allegan County Road Commission (ACRC) reinstate its: Culvert Policy back to a 50/50 cost share of culvert 36" and greater for the townships in Allegan County.

Kopka motioned to support the resolution. Supported by Pearson. Meert yes, Vandenberg yes, Kopka yes, Pearson yes, Horton yes and Shannon yes. Motion carried. Absent Morehouse.

Contract with County on Pagers/Fire Department

Pearson motioned to approve the contract with the County pertaining to repair and maintenance to the pagers when needed. (The contract does have more language in the contents.) Horton seconded. Motion carried.

The board set August 3, 2017 for the Public Hearing for Ordinance 165.

Fireworks

The board have received many complaints pertaining to the use of fireworks in the township, residents are not following State law which states that you can use fireworks the day before, the day of and the day after a National holiday. Kopka suggested we send a notice in our next newsletter reminding people of the rules. State Representative Whiteford was present and also stated there are concerns state wide with the problem.
