Bike Trail Plan

Suzanne gave an overview of the River to River Trail Plan it would be approximately 6.7 miles and the estimated construction costs in 2018 is approximately 284,000 per mile for paved and 61,004 for limestone. The board did not take action on this subject.

Roads, Road Mowing, Dust Control

Vandenberg reported the Allegan County will do two mowing's and Gun Plain Township will pay for the third. The dust control bid from SWB Enterprises LLC was \$12,615.00. Vandenberg motion to approve SWB Enterprises LLC and the third mowing. Pearson seconded. Motion carried. Roads projects for 2018, asphalt Airport Plat .47 miles, 107th Avenue .54 miles, Gun River Drive .44 miles and Sycamore Bend .19 miles estimated total for asphalt 196,800.00. Gravel projects 108th Ave. 1.69 miles, 2nd Street .98 miles and 3rd Street 1.53 miles estimated total \$50,400.00. Reconstruction projects 8th Street from Miller Rd to 106th Ave. to an all season road estimated cost approximately \$336,073.00. The board has committed to spending \$40-\$45,000 on 108th Ave. to cut trees down to help with the vision in that area. Shannon motion to accept the road proposals as presented. Horton seconded. Motion carried.

Perceptive Service and Operation Contract

The contract that they submitted came in with a 2% increase and the mileage will be reduced from point \$.70 per mile to \$.55 per mile. Kopka motioned to approve the contract. Pearson seconded. Motion carried.
